1. What NUTRILITE™ FIBRE POWDER is and what it is used for

NUTRILITE™ FIBRE POWDER contains digestion resistant maltodextrin, inulin and partially hydrolysed guar gum to help support your gut microbiome/flora health. Inulin, guar gum and maltodextrin in NUTRILITE™ FIBRE POWDER provides source of prebiotics. Prebiotics beneficially affects the intestinal flora by selectively stimulating the growth of the good gut flora to support intestinal health.

"A varied diet is the most effective and safe way to achieve good nutrition, health, body composition as well as mental and physical performance."

2. What you need to know before you take NUTRILITE™ FIBRE POWDER

Do not take NUTRILITE™ FIBRE POWDER

- If you are hypersensitive /allergic to active ingredients and any of the ingredients (see list in section 6.0).
- If you have a sudden change in bowel habit that has persisted for more than two weeks.
- If you are suffering from a blockage of the bowel (intestinal obstruction, faecal impaction)
- If you have a weakness of the bowel wall (colonic atony), the speed in which material moves through your gut has always been slow (naturally occurring reduced gut motility).

NUTRILITE™ FIBRE POWDER is not suitable for children under 12 years of age.

Warnings and precautions.

Take special care with NUTRILITE™ FIBRE POWDER. Consult with a health care provider prior to use:

- If you are pregnant or breastfeeding.
- If you are intolerant to fructose, galactose and/or lactose
- If you are taking medicines for any condition with blood sugar including anti-diabetics.
- If you are on any chronic medicines, prescription medicines or other medicines including over-the-counter medicines.

Children and Adolescents

NUTRILITE™ FIBRE POWDER is not recommended for children under 12 years of age.

Other medicines and NUTRILITE™ FIBRE POWDER

There is no known interaction of NUTRILITE™ FIBRE POWDER and other medicines. Always tell your health care provider if you are taking any other medicine including all complementary or traditional medicines. (See Possible side effects in section 4). This is particularly important if you are taking any medicines, fiber supplements may reduce or delay your body's absorption of certain medicines.

Take your medicines at least 1 hour before or 2 to 4 hours after taking NUTRILITE™ FIBRE POWDER.

You should check with doctor, pharmacist or your healthcare provider if you are unsure.

NUTRILITE™ FIBRE POWDER with food and, drink and alcohol
NUTRILITE™ FIBRE POWDER may be taken at any time of the day, preferably with a meal and enough liquid as recommended (See Section 3) without alcohol.

Pregnancy, breastfeeding and fertility

It may be possible to use NUTRILITE™ FIBRE POWDER during pregnancy and breastfeeding, only as part of a prenatal and postnatal supplementation. If you are pregnant or breastfeeding, think you may be pregnant or are planning to have a baby, please consult your health care provider for advice before taking NUTRILITE™ FIBRE POWDER.

Safety in pregnancy and breastfeeding has not been established.

Driving and using machines

NUTRILITE™ FIBRE POWDER is not expected to influence your ability to drive. However, you should not drive, use machinery or perform tasks that require concentration until you are certain that NUTRILITE™ FIBRE POWDER does not adversely affect your ability to do so safely (See Possible side effects in section 4).

Important information about some of the ingredients of NUTRILITE™ FIBRE POWDER:

NUTRILITE™ FIBRE POWDER Contains inulin, guar gum and maltodextrin and may have an effect on the control of your blood sugar if you have diabetes mellitus. NUTRILITE™ FIBRE POWDER Contains inulin which is a source of fructooligosaccharides and may be a source of fructose. NUTRILITE™ FIBRE POWDER Contains guar gum which is a source of galactotooligosaccharides and may be a source of galatose. Patients with the rare hereditary conditions of fructose or galactose intolerance should not take NUTRILITE™ FIBRE POWDER.

3. How to take NUTRILITE™ FIBRE POWDER

Always take NUTRILITE™ FIBRE POWDER exactly as described in this leaflet or as your doctor, pharmacist or nurse has told you. Check with your doctor, pharmacist or nurse if you are not sure. The usual dose is: Adults and Children 12 years and over: Take one (1) to two (2) powder per day, preferably with a meal and enough liquid or as directed by your healthcare provider. Dissolve contents of one stick pack in 250 ml of water or juice, or sprinkle on food. Stir until it dissolves.

Drink a full glass 250 ml of liquid with each stick pack. Do not exceed the recommended daily dose unless directed by your doctor.

If you take more NUTRILITE™ FIBRE POWDER than you should

In the event of overdose, consult your doctor or pharmacist. If neither is available, contact the nearest hospital or poison centre.

If you forget to take NUTRILITE™ FIBRE POWDER

Do not take a double dose to make up for forgotten individual doses.

4. Possible side-effects

NUTRILITE™ FIBRE POWDER can have side effects.

Not all side effects reported for NUTRILITE™ FIBRE POWDER are included in this leaflet. Not all side effects reported for NUTRILITE™ FIBRE POWDER are included in this leaflet. Should your general health worsen or if you experience any untoward effects while taking NUTRILITE™ FIBRE POWDER, please consult your health care provider for advice. If any of the following happens, stop taking NUTRILITE™ FIBRE POWDER and tell your doctor immediately or go to the casualty department at your nearest hospital:

- swelling of your hands, feet, ankles, face, mouth or throat, which may cause difficulty in swallowing or breathing.
- rash or itching.
- fainting.
- yellowing of your skin and eyes, also called jaundice.

These are all very serious side effects. If you have them, you may have had a serious allergic reaction. You may need urgent medical attention or hospitalisation. Tell your doctor immediately or go to the casualty department at your nearest hospital if you notice any of the following:

- chest pain
- angina
- changes in the way your heart beats, for example, if you notice it beating faster, difficulty breathing,
- signs of recurrent infections such as fever or sore throat,
- less urine than is normal for you,

These are all serious side effects. You may need urgent medical attention. Tell your doctor as soon as possible if you notice any of the following:

- nausea (feeling sick)
- abdominal cramps or stomach pains,
- headache,
- dizziness,
- tiredness,
- light-headedness,
- dry cough,
- muscle cramps,
- flatulence or wind,
- diarrhoea,
- loss of appetite.

If you notice any side effects not mentioned in this leaflet, please inform your doctor or pharmacist.

4. Moontlike nuwe effekte

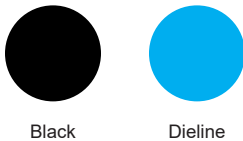
